**Summary Annual Report for  
LOCAL 802 MUSICIANS HEALTH FUND**

This is a summary of the annual report for LOCAL 802 MUSICIANS HEALTH FUND, EIN 13-6198844, Plan Number 501, for the period October 1, 2018 to September 30, 2019. The annual report has been filed with the Department of Labor, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

The BOARD OF TRUSTEES, LOCAL 802 MUSICIANS HEALTH FUND has committed itself to pay the following types of claims incurred under the terms of the plan:

- Certain medical, sick pay, prescription drugs, earplugs, and vision claims

**Insurance Information**

The plan has contracts with Fidelity Security Life Insurance Company of New York, Delta Dental of New York, Amalgamated Life Insurance Company, and Empire Healthchoice HMO, Inc. to pay the following types of claims incurred under the terms of the plan:

- Certain medical, dental, vision, and stop loss claims

The total premiums paid for the plan year ending September 30, 2019 were \$2,063,008.

**Basic Financial Statement**

The value of plan assets, after subtracting liabilities of the plan, was \$13,572,118 as of September 30, 2019, compared to \$14,488,815 as of October 1, 2018. During the plan year the plan experienced a change in its net assets of \$-916,697. This change includes unrealized appreciation or depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. The plan had total income of \$15,264,899 which included employer contributions of \$10,762,906, employee contributions of \$3,116,339, other income of \$431,148.00, and earnings from investments of \$954,506.

Total plan expenses were \$16,181,596. These expenses included \$1,704,060 in administrative expenses and \$14,477,536 in benefits paid to participants and beneficiaries.
