This is a summary of the annual report for LOCAL 802 MUSICIANS HEALTH FUND, EIN 13-6198844, Plan Number 501, for the period October 1, 2020 to September 30, 2021. The annual report has been filed with the Department of Labor, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

BOARD OF TRUSTEES LOCAL 802 has committed itself to pay the following types of claims incurred under the terms of the plan:

**Insurance Information**

The total premiums paid for the plan year ending September 30, 2021 were \$1,091,122.

**Basic Financial Statement**

The value of plan assets, after subtracting liabilities of the plan, was \$6,692,089 as of September 30, 2021, compared to \$10,442,719 as of October 1, 2020. During the plan year the plan experienced a change in its net assets of \$-3,750,630. This change includes unrealized appreciation or depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. The plan had total income of \$9,183,250 which included employer contributions of \$4,191,471, employee contributions of \$2,055,904, gain/loss of \$0 from the sale of assets, and earnings from investments of \$2,089,880

Total plan expenses were \$12,933,880. These expenses included \$1,477,050 in administrative expenses and \$11,456,830 in benefits paid to participants and beneficiaries, and \$0 in other expenses.
