**Associated Musicians of Greater New York - Local 802**

Pursuant to a letter of agreement with the Associated Musicians of Greater New York, Local 802, hereinafter referred to as “Local 802,” the American Arbitration Association, hereinafter referred to as the “Administrator,” agreed to conduct an Election of Officers.

Five Hundred Thirty-Eight (538) absentee ballots were mailed on Friday, November 1, 2024. Local 802 provided the list of eligible voters. The deadline to receive absentee ballots was scheduled for Monday, December 2, 2024, at 5:00 PM. Fourteen (14) duplicate requests were mailed out during the course of administration. Three Hundred Seventy (370) absentee ballots were received before the deadline.

In-person voting was conducted on Tuesday, December 3, 2024 at the following locations:

10:00 AM - 8:00 PM at the Actors Equity Association, 165 West 46th Street, 14th Floor Council Room, New York, NY 10036

12:00 PM - 7:00 PM at the Westside YMCA, 5 West 63rd Street, Parkside Lounge, New York, NY 10023


Three Hundred Twenty-Four (324) ballots were received during in-person voting.

One (1) absentee ballot was voided as it was hand delivered to the Administrator during in-person voting and received after the deadline. Three (3) challenged ballots were unresolved as the outcome would not be determinative.

The tabulation of results took place following the closing of polls on Tuesday, December 3, 2024, at the Actors Equity Association, 165 West 46th Street, 14th Floor Council Room, New York, NY 10036. The secrecy of the vote was maintained at all times. The results are certified to be as follows:
